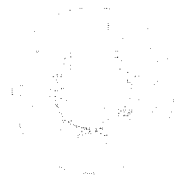

Dear Mr. Reilly:

We have reviewed an application from the referenced facility for an MSW permit modification dated June 16, 2011, and the revisions dated July 7, 2011, and September 15, 2011, requesting a name change for the permittee and the facility. Your application states that the name of the permittee will be changed to "Liquid Environmental Solutions of Texas, LLC" and that the name of the facility will be changed to "Liquid Environmental Solutions of Texas, LLC, Austin, Texas Facility". The information presented is technically sufficient for a MSW permit modification in accordance with Title 30 of the Texas Administrative Code (30 TAC), Chapter 305, Section (§)305.70(k)(13), and 30 TAC §305.64.

Enclosed is a copy of the referenced permit modification which is now part of the permit and should be attached thereto. The documentation prepared and submitted to support the modification and name change request shall be considered as requirements of the permit.

In accordance with 30 TAC §305.70(k)(13), you are required to mail notice of the permit name change no later than 20 days from the date of this modification approval. Please follow the instructions outlined below.

1. Mail notice in accordance with 30 TAC §39.106 to the current landowner list and all other interested or affected persons listed in 30 TAC §39.413, including persons on a mailing list maintained by the Texas Commission on Environmental Quality (TCEQ) Office of the Chief Clerk under 30 TAC §39.407. The text of the notice must comply with 30 TAC §39.411(b)(1), (2), (3), (6), (7), (9), and (12), and provide the website address where the application has been placed, in accordance with 30 TAC §330.57(i).
2. File a completed, original Certification of Notice of Issuance (form enclosed) and a copy of the mailing list with the TCEQ MSW Permits Section within 30 days after the notice is mailed. Include a copy of the notice with this certification.
